## MAIL THEFT DURING TAX SEASON

Mail theft is the #1 white-collar crime in America. This is a reminder to our residents that criminals are now targeting new developments with community mailboxes. These community mailboxes offer criminals a one-stop shop. Thieves are prying open the front door of the mailboxes to gain access to the individual mail slots. Typically, the door is damaged so severely, mail is halted and the entire cluster mailbox has to be replaced which can cost \$2,000 or more to replace. One of the main motivators in mail theft is to subsequently steal that person's identity and receive access to their private information, including bank accounts and credit cards. The following are some tips to help prevent/ limit your exposure to mail / mailbox theft:

Report any suspicious persons or vehicles near the mailboxes to your local law enforcement.

Report anyone tampering with mailboxes, especially late at night or the early morning hours.

Retrieve your mail as soon as possible after it is delivered. Don't leave your mail unattended for extended periods. Don't leave it in your mailbox overnight.

If you cannot regularly retrieve your mail promptly, consider obtaining a P.O. Box service from your local post office.



If you will be away from home temporarily, you can notify your post office to hold your mail.

Always deposit your mail in a mail slot at your local post office, or hand it to your letter carrier.

Monitor your bank account statements regularly, and report any charges or

checks you did not authorize.

Monitor your credit report and report any accounts you did not authorize.

Ask your bank for "secure" checks that can't be altered.

#### **PARKWAY MAINTENANCE**

Did you know that the parkway or "mow strip" in front of your home is a homeowner responsibility? Spring is a great time to pay some attention to this area to help keep our community looking fresh.

- 1. Check for and remove weeds
- 2. Replenish mulch, mow grass, replant balding groundcover
- 3. Trim tree shoots from trunk and remove dead growth
- 4. Remove tree stakes if the tree trunk has become larger than the stakes. If stakes are not ready to be removed, make sure they are standing straight and tall, and that the tree is securely tied between them.
- 5. Planning something different? Don't forget to file an architectural application and receive approval prior to beginning your project.

# **DAYLIGHT SAVINGS FUN FACTS - MARCH 14**

In the United States, daylight saving time begins at 2:00 a.m. on the second Sunday in March and ends at 2:00 a.m. on the first Sunday in November.

Daylight saving was chosen to start at 2:00 a.m. because it is when the fewest trains were running, and it prevents the date from switching to yesterday. Additionally, 2:00 a.m. is before most shift workers leave for work, and it causes minimal disruption to bars, which close at 1:59 a.m.

Benjamin Franklin was the first to suggest a change in sleep schedule in 1784 after visiting Paris. In a witty essay titled, "An Economical Project for Diminishing the Cost of Light," he calculated, jokingly, that Paris could save \$200 million in candles of today's dollars if they adopted daylight saving time.

When daylight saving time was extended in 2007, there was a 7% decrease in crime in the U.S.

"Cyberloafing," or surfing the web for enjoyment during work hours, increases significantly the first Monday after daylight saving time begins in the spring. Researchers attributed this increase to lack of sleep and thus lack of focus and motivation.
