including for purposes of business or vehicle maintenance. Any vehicle that is parked in a fire lane or in any manner that obstructs



free traffic flow, constitutes a nuisance or creates a safety hazard, or violates these rules may be towed away at the vehicle owner's expense.

Recreational, commercial, and inoperable vehicles, as well as those displaying advertising, are considered prohibited. Prohibited Vehicles may not be parked, stored or kept within the Property except for brief periods for loading, unloading, making deliveries or emergency repairs.
